2. Booth number will be assigned by the Gage Pitman Memorial Rockin' Reds Fishing Tournament Committee.
3. Cost of space is \$25.00 for both days Arts & Crafts and Commercial.
4. Size of Space: 10' x 10'.
5. Event Hours: Sat, May 3, 1 pm – 6 pm (or until weigh in is over) Sun, May 4, 11 am – 5 pm. Vendors are obligated to remain open during the event hours. All booths must be removed from the area on Sunday evening.
6. Vendors may start setting up on Saturday at 10 a.m. and set-up must be completed and all vehicles removed from the area by 12:30 pm. Set up on Sunday will begin at 9 am and vehicles removed by 10:30 am. Vehicles will not be allowed to return until after the event closes.
7. You are responsible for your own tent, tables and chairs. **All tents must be secured in a manner to prevent them from blowing away in the event of wind/bad weather.**
8. Items left over night will be at your own risk.
9. All vendors are responsible for collecting and reporting the Florida Sales Tax.
